- 2. No Personal Benefit. The Donor Advisor(s) shall not receive any personal benefit in exchange for facilitating the Distributions, nor shall they have any control of the Gifts or Distributions once received by Gaia.
- 3. No Pledge Agreement. This Letter of Intent is a statement of the Donor Advisor(s)'s present intention only and it is not intended to be a legally binding pledge
